

Hierarchy Of LAW – *Understand the Order of LAW and Where you can stand in the matrix of real and fictional roles of society...*

Universe or GOD - Unknown but Knowable... As all stem from the original sustaining source, no one has exclusive use over anything or anyone...

Natural LAW - All creatures experience these rules as part of Life...

Lawful Realm - Reality, from which the People's 1st simple set of Rules to obtain 'Fair and Equitable' outcomes originate, based on Natural Law.

*Living Creatures, Men & Women, going about their tasks of living a **Private** Life.*

- **Legal Realm** – Public Fantasy or Fictional entities, the People's 2nd set of Rules of very complex and unwieldy manifestations...
- All **Public** activity is where operators, players, and transactions must be transparent, so all can see what is done is **Fair and Equitable**, honest, honourable, truthful, respectable, in line with the '**Lawful Realm**' and reflects '**Natural Law**'. (no privilege, no oppression)
- Since 'Sumerian Times' and may be well before; '**the Living People**' established the Rules for the 'Legal Realm' to follow.
- **People's Authority** --- Ultimate Authority is always from the **Living People**, to operate 'Legal Fictions', be they recent or long established entities.
- Living Men & Women take on special roles in 'fictional entities'; e.g. Parliament as Representatives, Executives, & Judiciary.
- **Government Operates as a Public Trust, for the Benefit of all People**, as trustees to administer Governance, Commerce and Trade in the 'Legal Realm' to facilitate 'Domestic and International' operations, non-exclusively, as the Living still need to deal with the Living in the Lawful Realm.
- These Legal Rules, set by a Constitution, to convene a Parliament, to limit it's Powers, and place in oversights and protections for all.
- Rules 'Deemed Laws'; by mutual, ongoing, full disclosed and wilfully agreed to, as contracts, by all parties involved.
- Fictional Rules that can be refereed to a 'Competent Legal Judicial Arm' of any Government, with a Jury of Peers to form a
- **People's Court** --- 'Trial by Jury', not a 'Jury Trial', to review evidence and nullify any unlawful legal rules. (Statutes as legal laws, regulations, by-laws...)

You May Trade with others as Living Souls, exchange Goods & Services for equal value privately but try not to use Gov. issued legal tender, to stop falling under that jurisdiction & set of rules.

- All '**Legal Realm**' entities should be '**non-living**' entities, that can only be operated by the '**Living**', **never by themselves**.
- To assist, all Men & Women have a Government assigned fictitious 'Legal Entity', that may match their 'Birth Name' and 'Date of Birth'.
- This fictitious entity might share your details, it is a creature and property of Government, it is not yours, nor is it really you, but it is a Gov. token of you, which you can be an Agent for, in the Gov. trust configuration, if you agree to the Terms & Conditions *
- that Representatives, Executives, and hired Gov. Boffins set, as per their respective contracts, agreements, oaths, to administer...
- You may have a Business that also trades under the same name, or any other name, it may be tied back to this Gov. Legal Entity.
- *As Gov. already has a fictional version of you, their push for all to have a Digital ID is suspicious and goes beyond the powers granted by living Men & Women.*

The People used to use Gold and Silver Coins or redeemable vouchers as Private issued currency... i.e. UK Bradbury Pound, Aust. Holey Dollars... and today it is Digital Bit Coins.

- * **Joinder**: of You, the 'Living Soul', to this 'Gov. Legal Entity' needs serious consideration; as protections can be lost and if penalties are applied to the Living unlawfully. i.e. false assertions by Gov. robo-debt, automatic fines for vehicles and homes, failure to renew, comply or pay on time, because de-banked by 3rd parties, or a lack, or breakdown of infrastructure...
- **Gov. works for the People**, not the other way around, stand your ground, **know your Rights**, know which realm you operate in...
- e.g. Trade for Goods and Services done in a Government issued currency, as fiat, digital or other Gov. tokens;
- Sets the conditions for which appropriate 'Legal Authority' rules apply. (i.e. Domestic or Foreign Government...)
- Payments are a problem when a third party gets involved (a bank, a Gov.), with delays, questions, or denies the transaction;
- Like a Cheque, Promissory Notes (P.N.) were created, long ago and are still valid today, to assist trade by the 'Bills of Exchange (BoE) Act'.
- If you have the Credit, but no access to it yet; a signed P.N or BoE is still a convenient way to trade with those that accept such.
