

# ⚖️ Hierarchy of Law ⚖️

Understand the Order of Law and where your place is in this Universal Trust.

## Cosmos or Creator - Original Sustaining Source and (God) Creator of all things, *the Grantor*.

- Any 'ONE' that creates a thing, always 'Holds Title' to their thing, their Creation.  
As all are part of the Universe or GOD, all are equal 'Holders in Title', as all are 'ONE'. \*\*
  - The Creator of all things in the Universe is unknown but knowable through each of us.
  - Natural Law ... **The Lawful Realm - Living Men and Women - *The Beneficiary & Executor*.**
    - **<You are always Here>** *You can never surrender or lose, only suspend willingly, your in-a-lien-able Rights.*
    - Reality of living life, in private and in public, is keeping the peace, cause no harm, remedy any harm done. To know imperishable Rules of Reality, Societal Rules of Conduct, Honour and Integrity. Rules that All Creatures Learn, as 'Facts of Life' during life.
    - What one can do, all can do, as no one, is special or privileged, as all are 'ONE'. \*\*
    - A choice, life or death, to Cooperate or Compete, for mutual Survival and to Prosper.
    - Lawful Common Law or Lore: People's 1st Set of Legal Fictions according to conscience as Customs, Birthrights & Practices. Guidelines for society to function, in Lore and Equity.
  - Artificial Law ... **The Legal Realm** - Rules, People 'Deem as Law' in any fictional world. All Civilisations are fictional in order to administer the functions of State, for record keeping of things & tasks.
  - Government - **The Trustees**. The People's 2nd Set of Legal Fictions: Governments do not create anything, they hold no title, they are Trustees, bound by a Constitution, Granted by the People, to administer only what the people have to grant, their common created things and 'Resources' the Universe or God provides for the benefit of all creatures, in line with mutual survival and good stewardship.
  - Government is also a venue to discuss the mitigation of harms and loss, the people identify and must approve any solutions by mutual consent, before implementation. As Trustees under Public Law each contractor, employee or representative agree by oath or contract to deliver good 'Governance, in Commerce or Trade'.
    - Any failure is under pain of personal liability, according to their fully disclosed *Contract or Trust Deed or Oath* they signed Willingly, in Honour and integrity under the Clean Hands doctrine.
  - Separation of Government Powers: *Constitutionally equal authoritative entities: Representatives., Executive. & Judicial, report to the Crown, 1<sup>st</sup> of the People's equal as Head Trustee.*
    - Crown - Royal Assent, 1<sup>st</sup> Check that No Harm or Loss to the People through Statutes, Deemed as Law.
    - Parliament – Representatives from the People form an Executive, to administer Common Resources. Form Legislation into Statutes that 'the People' ask for to mitigate Harm or Loss.
    - Court – Judicial / People's Jury, 2<sup>nd</sup> check that Statutes cause no harm or loss, are in line with Common Law, to settle arguments on Public or Private Disputes, using logic, reason & applicable rulings.
  - Legal Fictions – Creation of Living Men & Women as administrative tools of the Nation State. **Government, Business, Corporations, Trusts, Charities, on to Public Servants (Trustees) and Citizens** (Beneficiaries & Executors). All legal fictions can only be operated by the living. By impossibility no legal entity can operate itself. The operator must be identifiable to be valid, anonymous operations are invalid and void.
  - *All 'Legal Fictions' are played by a 'Living Man or Woman' as operator. When their operation causes harm or loss to another Living Man or Woman in the Lawful Realm of Common Law, this is a Crime, and there must be an injured party, a victim of, and in the real world.*
  - *Legal fictions are Imaginary entities and can not be harmed or incur loss, being 'constructs of the mind', they can only cause offence or be offended against, according to the Statute(s) or Rules that they operate under.*
  - *The Legal trick of joinder between the living and the fiction is an unconscionable, unlawful, deceptive short cut to achieve a perverted outcome, with fiduciary and punitive consequences on the perpetrated, and if challenged correctly, back on the perpetrators. Know and reserve your Rights, Refute all Presumptions, establish the Facts!*
